



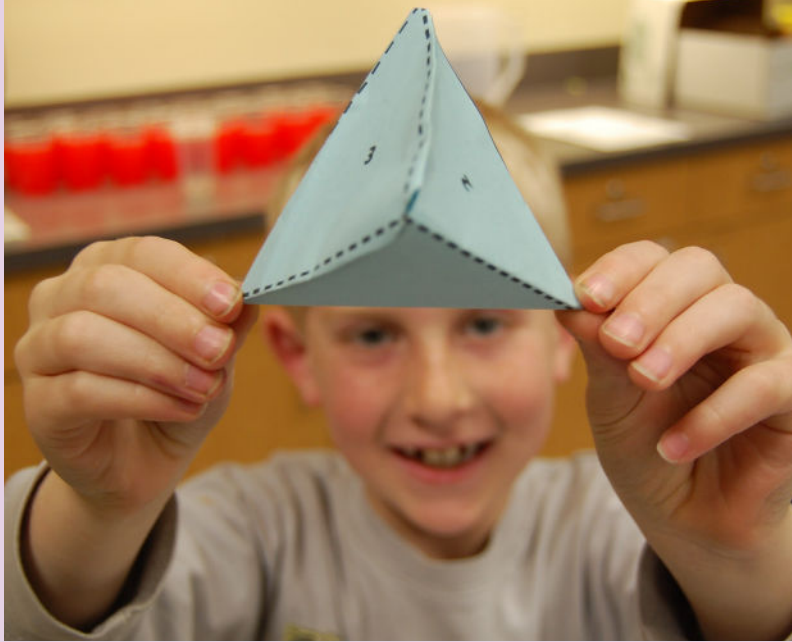

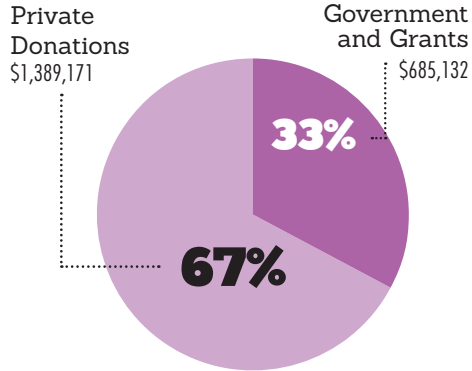






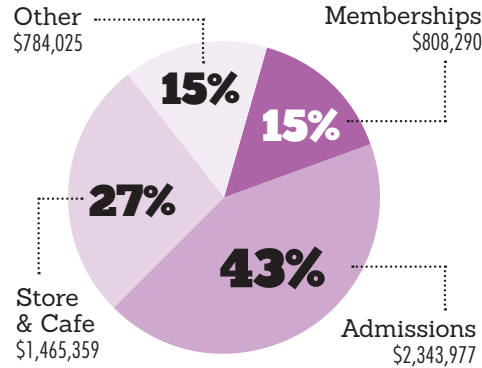

## Contributed Revenue



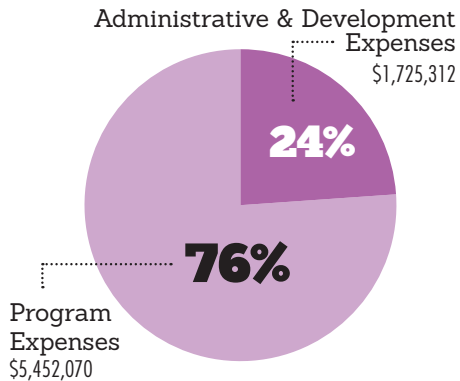
**TOTAL CONTRIBUTED REVENUE:**

## Earned Revenue



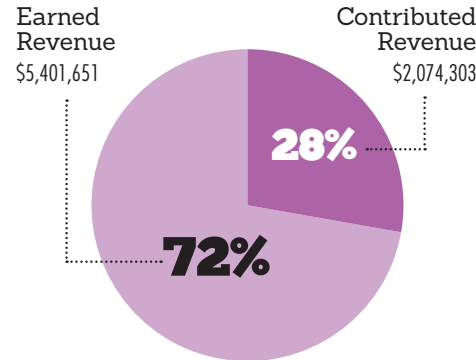
**TOTAL EARNED REVENUE:**
